Viscose	Viscose fibers are produced from cellulose pulp. Cellulose is dissolved in alkaline solution by a chemical reaction with carbon disulphide and then spun to fibers in an acid spinning bath. The fibers are washed, dried and cut to intended fiber length.
Polyester	Polyester fibers are produced from terephthalic acid and ethylene glycol, which react through condensation to polyester resin. The molten resin is spun to fibers through spinnerets and cooled with air. The fibers are then cut to intended fiber length.
